## Internal & external compliancy reviews of RSHE

The PSHE Partnership (previously the RSHE Partnership) has spent since 2019 preparing schools to effectively deliver RSHE as stipulated by the DfE Statutory Guidance from the DfE. Most schools are doing an amazing job at teaching this new curriculum, but may still feel that they want to ensure that their policy, curriculum content, parent engagement and the confidence and ability of staff to teach RSHE are compliant with the guidance. To support schools in this The Partnership are able to supply schools with three levels of review. Documents have been devised, by way of:

1. A questionnaire for pupils
2. A questionnaire for the RSHE Lead
3. A compliance matrix (which outlines curriculum areas that should be taught and how teaching should be carried out), which outlines the 2019 RSHE statutory curriculum and also gives guidance on how the content should be taught.

There are three levels of review that can be carried out in schools.

### **1. Basic Internal review**

Providing documents for a school to carry out their own compliance review.

These will be licensed to individual schools and should not be shared, even with in MATS.

**Cost: £150**

## **2. Supported internal review**

Documents provided and then worked through with the Advisor to ensure compliance with the statutory and additional guidance. Support and advice given where needed.

**Cost: £350 for half day  
£650 whole day**

Any additional time needed will be charged at £250 a half day

## **3. Independent external review**

This will include the above, but also a website, policy and curriculum review, pupil consultations, book look and staff discussion. A written report can also be commissioned.

**Cost: Bespoke prices arranged depending on the size of the school and the amount of support needed**

# Whole School PSHE Training

Everyone in school is responsible for protecting the school ethos. P/RSHE supports your school ethos and the whole school community should be aware of their role in modelling quality relationships, adhering to the law and supporting the school in the delivery of high quality, evidence based and student sensitive P/RSHE.

Training for a whole school community is important for a unified approach to creating a safe, enabling, and enriching space for children and young people to thrive.

This training is for everyone involved in schools, site supervisors, management team, teachers, learning support staff, lunch time supervisors, kitchen staff and cleaners.

# SCITT Training

There is very little training for teachers concerning P/RSHE, but as most teachers will be required to teach the subject either as a form or class teacher, or in some cases, as a specialist, it is important that it is included in any initial teacher training.

This training will equip trainee teachers to:

- Understand the curriculum
- Identify the links between P/RSHE, school ethos, the health and wellbeing of pupils and other curriculum areas
- Know about the law, Ofsted framework, teachers terms and conditions and the RSHE guidance (DfE, 2019)
- Answer tricky questions, and handle difficult discussions with pupils or parents
- Become confident in their delivery of P/RSHE

# Governor Training

Schools have found that an informed Governorship, that understands the importance of P/RSHE, knows their responsibilities concerning RSHE and the links RSHE has with the whole school ethos and pupils wellbeing, is a Governorship that can support the school and also provide positive links with parents.

The course can be bespoke to any setting, but is normally 2 hours long and encourages governors to:

- Recognise their responsibilities and the context in which the school is situated
- Appreciate the importance of P/RSHE for the wellbeing of pupils and be aware of the statutory guidance concerning RSHE (DfE, 2019)
- Understand the law concerning education, equality and safeguarding
- Know their role in the school, especially concerning the RSHE policy and the importance of parental consultations

## Parental Consultation and Updating RSHE Policy

We can provide support in holding your parental consultation and updating your RE Policy to ensure your school remains compliant throughout.
